### Ahmedabad

#### Adani VidyaMandir (AVM) in Action!

The Adani Vidya Mandir (AVM), a school under the aegis of Adani Foundation is a unique concept which provides cost free quality education to meritorious students coming from underprivileged backgrounds. Adani Vidya Mandir, Ahmedabad is a CBSE affiliated English medium school and is the first of its kind initiative. The students, most of them being first generation learners, have priceless treasures of desire and ability, but lack of resources play deterrent in making them chase their dreams. AVM supports the dreams of those children and their parents who owing to their financial constrains are not in a position to provide quality education to their children.

### Major activities held at AVM during last year were:

Student Exchange Program - Six students from AVM Ahmedabad visited Slovenia in April as part of the student exchange program. During Navratris Slovenian team visited AVM A. The program gives students the required exposure and also helps them have a greater understanding of the different cultures.

Rinku Rajpal, a 12th standard student of Adani Vidya Mandir was selected as a winner of IGNITE-2014 Awards organized by the National Innovation Foundation (NIF), Her innovative idea of a voice modulation system was felicitated by our Former President Late Dr. APJ Abdul Kalam at IIM, Ahmedabad.









- Under the National Campaign on Energy Conservation 2014, 36 students participated in Painting Competition and our two students Contractor Manthan B V C and Master. Talaviya Yagnik received 1st & 2nd position respectively.
- Students from AVM A also participated in the International Mathematics Olympiad held at Hyderabad. Master Sidhharth Bhuva achieved 25th rank at State level, for which he received Gold medal of excellence 8 certificate of excellence.
- The major objective of the school is to take learning beyond the text books and outside the classrooms. Therefore, a number of exposure tours that include movie showcasing, educational trips. Some memorable ones being Tribal museum, nature park etc. These activities help students get a practical view of the teachings at classes.
- In order to promote books and reading, International School Library Month was celebrated in the month of October. Students participated in a workshop for creating hanging stories and had the author Dr. Shraddha Trivedi giving a glimpse of the rich Gujarati children's literature.
- AVM focuses on overall personality development of the students. AVM strives to inculcate a sense of team spirit and healthy competitiveness among our students through a number of inter house competitions like quiz ,skits, patriotic songs, rangoli competition etc. Also, all social and national festivals like Teachers' Day, Janamashtami, Ganesh Chaturthi, Dassera, Diwall are celebrated with great fervor.
- Special focus is also given to teachers' training program through a number of workshops and seminars organized from time to time. The school organized a six day long training program entitled 'We, The Teachers' for the personal and professional enrichment of the teachers.


### 1. M-ken Project - On The Path Of Improvement In Education

KAIZEN is a Japanese philosophy of continuous improvement in working practices, personal efficiency, etc. with your own range of vision. This is how the project of working with the students from 3rd to 8th standard was started by Maa Foundation and adopted by Adani Foundation. The project gathered momentum in the second month of its implementation. With the project being implemented in 26 schools, 4592 students of 3rd to 8th standard were tested for their scholastic performance, out of which 961 students came under the minimum level. These 961 students were taught by Shikshak-Mitras of Adani Foundation for a year. In the month of August, they were taught module LZR (learning to read) i.e Gujarati using various games, flash cards and other activities. The objective of L2R is to make students clear with the basic Gujarati. Apart from being on field, the Shikshak Mitras are continuously monitored and evaluated by Community Mobilisers of M-KEN Project. Regular Meetings were also held at field office so that their progress, the problems they were facing and the solutions can be exchanged with the big group.

In the month of November, Personality Development Camps were organized for the schools of M-KEN Project. This five day long Personality Development Camp titled "Sharadutsav" in schools was conducted from 5th November - 9th November 2014 at 11 centers for the students of 3rd - 8th standard in which 805 students from 26 schools participated.



9049 students have benefitted from the M-KEN Project through its various activities throughout the year:



#### 2. Disha Project - Directing The Right Career Path

Disha Project works with the students of 9th – 12th standard. A career talk is given to the students which includes a video showing various career options after 10th std and after each stream i.e arts, commerce and science. After the career talk is delivered, a psychometric test is taken with the help of the software exclusively designed to test the following abilities of the students:

- Numerical Mechanical Verbat
- Spatial Clerical Reasoning

On the basis of the answers given by the students with the help of remotes, result is generated and three suitable careers are suggested to students on the basis of three parameters:Interest, personality 8 ability.

### 3 Science On Wheels And Maths Fair - Learning Becomes Fun

The objective of this project is to take Science and Maths in a fun and friendly manner to the primary schools. The van filled with science models goes to the primary school and stays there for a day. In the first half of the day, students from 5th to 8th std are explained about the various models of science ranging from the models of human body, human brain and models of physics as well as chemistry. In the second half of the day, the students participate in hands on activity and Maths Fair. In hands on Activity, the students are divided into groups and are given working models like wind mill, racer, etc. In a jumbled form. They arrange the models and set them working. In Maths Fair, different activities and games are set up in which students participate and learn the concepts of mathematics in a fun and friendly manner.

Parvarish is the name of residential camps organized for the students of 9th – 12th standard during vacations. The objective of this five day long residential camp is to develop the personality of the students so that when they go in the outer world they can face the competition and sustain themselves.

### 5. Sara Samachar - The Good News

Every good happening around us should reach the maximum number of people. With this objective in mind, the concept of Saara Samachar was introduced by Dr. Bhadrayu Vachhrajani, Director-Education, Adani Foundation. The first edition of Saara Samachar got launched on 16th October 2014.

### 6. Educational Vocational Guidance Fair (EVGF)

The objective of EVGF is to benefit those students who study outside the Mundra block and thus three EVGF were conducted at Bhuj, Rapar and Nkhatrana.

The fair is divided in two parts- in the first part, the students are given a career talk by the staff members of Adani Foundation and thereafter the students go through 42 career charts that form part of the career exhibition. Thereafter the psychometric test of the students is taken and along with the results a booklet is given to them for future reference.

The first Educational Vocational Guidance Fair was organized from 28th November 2014 to 4th December 2014 at Alfred High School, Bhuj.

### 7. Learning Delight

Installing the "Learning Delight" software in 50 schools of Mundra Taluka is another educational initiative by Adani Foundation. During the last six months, the working of the software was supervised. A Teachers' Training was organized for the teachers of Mundra Block to use Learning Delight software. This training was organized on 17th January 2015 in collaboration with Learning Delight and BRC. The objective of the training was to give input to the teachers to perform more efficiently and to make them more science friendly.

#### 8. Adani Vidya Mandir, Bhadreshwar - The School With A Difference

Adani Vidya Mandir, a unique Gujarati medium school was started in June 2012 at Bhadreshwar village of Mundra Taluka. The objective is to provide free education to children of fisher-folk community and economically challenged families. The Foundation provides nutritious food to the pupils including breakfast, lunch and snacks every day. Special care is taken to provide high quality education and overall development of the children. The children are groomed to go back to their families and communities and be the agents of change.

In the Year 2014-15, Adani Vidya Mandir became a school providing education from 1st to 8th standard, with a total strength of 376 Students. Remedial Classes are also organised at the school which are additional coaching for newly enrolled students to help them cope up with new syllabus.

The Annual Day Celebration was held on March 9, 2015. Dr. Priti Adani, the Managing Trustee of Adani Foundation and Sh.Kantisen Shroff, prominent personality of Devlopment sector were the special guests on this event. It was witnessed by around 700 parents, village leaders and teachers of other government schools.

#### 9. ADAV Mundra - A Prestigious School

Established in 2001, Adani DAV Public School at Mundra has been associated with the DAVCMC- Dayanand Anglo Vedic College Managing Committee from the very inception and is considered the best school in Kutch region. This school is a K-12 school and provides Science and Commerce stream in Senior Secondary Examination. It follows CBSE Curriculum from 9th to 12th class and till 8th class the DAV Curriculum is followed.



The school provides holistic and child centric education with a vision to produce confident global world leaders with deeply embedded Indian values and ethos.

The school has been doing an excellent service to the community around and also to the Adani group employees. This school has the rare distinction of being rewarded with the prestigious ISA -International School Award conferred by the British Council, the kite mark of the same will be used by the school till March 2018. The school has set very high standards in all the school activities, may it be academics, cultural or sports. During this year the school has a strength of 1530 students which brings it in the category of a big school as per CBSE norms.

### Student Exchange Program - Learning from Different

Adani DAV Public School, Mundra and DAV Public School, Gurgaon have joined hands to initiate Student Exchange Program in which the students get a chance to increase their understanding and tolerance for other cultures, as well as improving their life skills and broadening their social horizons. 13 students and 2 teachers from DAV Gurgaon School visited our school as part of the School Exchange Programme and were at Adani DAV Public School, Mundra from 16th to 23rd July 2014. During their stay they trained students for MUN and performed a street play on the theme of 'Women Exploitation'. They took an industrial visit of Adani Port, Power and Wilmar. They were also taken to Bukhari Pir Dargah at Mundra, Kranti-Teerth-Shri Shyamji Krishna Verma Memorial, Vijay Vilas Palace and beautiful Beach at Mandvi. They also learnt about the crafts, heritage and cultural ecology of Kutch at 'Khamir' near Bhuj where they were introduced to pottery, tie and dye and weaving of plastic bags.

#### Project 1600- Conserving the Marine Ecosystem

The school has been a part of Project 1600, an initiative of CEE India, Adani Group, IUCN-GPCB of the Govt. of Gujarat, UNESCO and CEE Australia. The objective of the project is to generate awareness of, interest in and passion for the conservation of coastal and marine ecosystem among children and youth. It also aims at the study of human impact including urban habitations, industrial growth, ports and urban livelihood activities on these ecosystems. The students of the school, under the project, have contributed towards sustaining marine ecosystem.

### Celebrating Annual Day–A Cultural Bonanza

The School Annual Day is one of the most awaited events of the school as each and every class gets a chance to perform on stage and leave their footprints on the hearts of the audience. This cultural extravaganza was held on 15th, 16th and 17th of October 2014 for classes IV to XI and for classes II and III it was





held on 12th
December 2014.
Students were
given different
themes. Classes II
and III got the theme –
'Retro to Metro'. They
dressed themselves in
retro style and performed on
the songs of 70s and 80s. Classes

IV and V got the theme – 'Rishtey'. They grabbed this opportunity to display various human relationships. It was a heart touching moment when they thanked their parents and teachers through their performances. Classes VI to VIII got the theme – 'The World of Dance and Music'. A variety of dance forms were exhibited. Classes IX and XI got the theme – 'Sanskar'.

The students presented a mixture of programmes like melodious group songs, scintillating dances and message giving skits. They were looking stunningly beautiful in their colourful costumes.

### Annual Sports Day

The students persevered in the open field of their Sports Ground during the two day long Annual Sports Day held on 19th and 20th December 2014.

The students from 2nd to 11th standard were divided into four groups. They participated in various events like 100 m race, 200 m race, 400 m race, long jump, discus throw, shot-put etc. and exhibited their strength. The attraction of the first day was senior boys' and girls' 4x100 m relay race whereas on the second day teachers' race stole the show.

The atmosphere during these days was filled with the feelings of firm determination, sportsmanship and the indomitable spirit of fighting till the last to grab a medal for the house. The students were cheering their house participants with different slogans and claps.



#### Sports - ADAV Mundra

#### Badminton

Four boys and three girls from the school went to Jamnagar to participate in U-19 state level Badminton tournament while three boys participated in U-14 state level tournament held at Baroda.

#### Throw Ball

The school participated in various state level Throw Ball tournaments. Five girls participated in U-14 tournament held at Palanpur and secured first rank. Out of them Moksha Sharma was selected for the National Level tournament. Similarly, four girls took part in U-17 tournament held at Himmatnagar and their team won it. Seven boys and two girls participated in U-19 tournaments held at Ahmedabad. The girls' team won the finals. Master Patramal Seda of the school was selected for the national level tournament.

#### **Table Tennis**

The school encouraged the students to participate in Table Tennis tournaments as well. Three boys participated in U-19 state level tournament held at Surat and two boys participated in U-17 state level tournament held at Mehsana.

#### Football

Four boys from the school were selected for U-17 state level Football tournament which was held at 8haruch. The team reached the quarter final stage.

#### **Ball Badminton**

Five boys and five girls participated in U-19 state level Ball Badminton tournament held at Morbi.

Two boys from the school got the opportunity to participate in U-17 state level Net Ball tournament which was held at Ahmedabad.

### International School Award (ISA) Journey - An Endeavour towards Borderless World

On September 2013 Adani DAV Public School was invited to a Seminar held by the British Council. We got the privilege to become a part of the 'International School Award Scheme' till March 2018. After the registration process the school formed the coordinating committee to chalk out the action plan for ISA.

There were 24 activities of 12 Projects. It was mandatory to have International Dimension in each activity. It was compulsory to involve 90% of the staff and students covering all the subjects.

We participated in various activities like Migratory Birds, Human Rights, Learning a foreign Language – Urdu, Physics Corner having the models based on principles and ideas of two Nobel Prize Winner scientists, Einstein and Dr. C V Raman, International Kite Making, International School Meals Day etc.

Under this program we have provided the software in schools which can be used as a tool to enhance teachers' effectiveness. 11 schools benefited.

### 3.Science on Wheel- Reaching out to the Rural **Students**



"Science on Wheel" project came with an objective to reach out to the students of rural India and to give them the opportunity to learn the basics of science through science models, games, hands on activities, experimentation etc. The Foundation started this project with a hope that early intervention would help students in expanding their knowledge content by creating their own knowledge by experimenting with the things present around them. "Trial & Error method" is the best

way of creating new and self-knowledge which willprovide students with the apportunities to grow, 766 students from 7 Schools benefited from this program.

#### 4. Disha - Career Guidance Program

Disha program is a career guidance program where direction is given to the students while choosing their career. The program aims to help students in keeping the pace with the changing world which is growing every single second by informing about newer & broader opportunities which are already available and other which would emerge in coming future.

#### 5. BaLA Project Implementation

Learning is always a fun and to develop this attitude especially In the govt, school students, the Sarva Shiksha Abhiyan (SSA) has come up with BaLA i.e. Building as Learning Aid. The activities are planned in such a way that each student as well as teachers will be involved in the activity. The first phase was all about coloring their schools and walls with the pictures of Computer, Solar-System etc. and the next phase was about how we can make those pictures alive which would help students in enhancing their capabilities of exploring things which are present around them not only on the walls but also outside their classrooms.

#### 6. Scholarship Support

The scholarship support was provided to 484 students from 13 schools to motivate them as well as other students also to perform well in their studies.





### Dahej

### Learning D-Light Program - Maiding Learning a Delightful Experience

Learning D-Light Program was Introduced in Government schools at Dahej by Adeni Foundation in order to encourage a techno-friendly learning environment for children so that they could keep pace with the present challenges.

Also, Smart Class was set-up at Dahej Kanya Shala to facilitate students with the benefit of E-Learning. This was one of the initiatives taken up for promotion of Girl Child Education. More than 400 students benefitted from this initiative.

### 2. Scholarship Distribution - Encouraging Students

Scholarships worth Rs. 3 Lakhs were given to meritorious students of all schools coming under Dahej site. This initiative was taken to encourage students to continue performing well in classes and taking interest in education. A total of 294 students were given scholarship.

### 3. Play 2 Lead- Rural Sports Development

Adani Foundation initiated Rural Sports Development by engaging an organization namely Play 2 Lead specifically to inculcate the spirit of rural sports amongst the school students and youth of the villages. The students were given the knowledge of importance of discipline, coordination, group work, work ethics, team work, confidence etc. through engaging them in rural sports. More than 300 students benefitted from this.

### 4. Teachers' Training - Capacity Building of the Teachers

A Teachers' Training Program on 'innovative Teaching' was given to 24 selected teachers from all schools of Dahej site. This was very much appreciated by the teachers and they found it to be extremely useful.

### 5. Bala Work Utilization - An Interesting Manner of Learning



The idea is to engage children in learning process through fun activities. The activities are planned in such a way that each student and school teachers get involved in the entire activity. The idea is first to make the school building as the learning aid for the child. The buildings are painted with colorful pictures which focus on improving the child's learning through attracting them towards different forms of designs, pictures and colors used. The paintings themselves give a holistic view of the learning to the children in their class or from their books but in an extremely interesting way, 1120 students have been benefitted from this initiative so far.

#### 6. Sports Week Celebrated

Sports Week was organized in close coordination with Ramatotsava that is a government initiative. About 1500 students participated in the Sports Week in different sport matches. This included Kho-Kho, Cricket, Kabaddi, Volleyball, Leg-Volleyball, etc.



### Tirora



### 1. Launching of UDAAN Programme - Practical Knowledge on a New High

UDAAN Programme was launched on the eve of Teachers Day on 5th Sept'2014. UDAAN Programme was organized for students from 10th and 12th std. It is a one day field trip (Exposure visit) to Adeni Power Mahereshtre Limited Tirode. Adeni Foundation takes students to Adani Power Unit at Tiroda where students get exposure of technical knowledge about power generation, environment, rural development, safety management functions, various kinds of machines and its role in power generation. Visiting Adami Power plant help students to enhance their concepts regarding practical aspects of operation in coal fired Power Production. The objective of UDAAN is to give information about various sources in power production and motivate students to think actively about their careers. During the year, a total of 19 visits were conducted for 883 students and teachers from 10 High Schools. Students were encouraged to dream big and pursue their dreams.

### Special Classes at Government School -Nevodya Coaching Classes

The Novodaya Vidyalaya is a unique experiment in the annals of school education in India and elsewhere, its significance lies in the selection of talented rural children as the target group and the attempt to provide them with quality education

comparable to the best in a residential school system. It was felt that children with special talent or aptitude should be provided with opportunities to proceed at a faster pace, by making good quality education available to them, irrespective of their capacity to pay for it. The prime objective of this program was to provide quality modern education to the talented children predominantly from the rural areas, regardless of their family's socio economic conditions and ensure that all potential students get quality education through coaching. 25 students on regular basis were enrolled and two teachers were recruited for teaching on regular basis for 7 months. Monthly exams and parents meetings are conducted on regular basis and topper students are felicitated. Also, books were distributed by Adani Foundation.

### 3. E-Learning support

In the year 2014-15, an E-Learning software was installed in nineteen pilot schools by the Adani Foundation. Taking into account the tremendous response it got, it was to further install E-Learning packages in one more school and it was successfully done. The E-learning which is a complete package of software and hardware has been proven an efficient learning tool for teachers as well as students. During the impact assessment of the five units installed, it was found that students liked the E-learning Programme and found it



very useful. They also shared that their learning abilities have increased considerably which was proven by the increased marks in the subjects year by year. Total 201 students from 5th to 10th std took benefit from this E-Learning program.

#### 4. Exposure tours



### Educational Tour to Raman Science Center at Negpur for atudents and Teachers

Educational tour to Raman Science Center was conducted to introduce students to various inventions in the field of science. Students thus, can establish concept of how to present and test their ideas independently and increase the interest in science among students and also increase their grasping power. In this tour a total of 1047 participants visited Raman Science Center. After coming back an essay writing competition on "Visit to Raman Science Center" was given to students for submission.

#### Science Exhibition Exposure Visit toTirora

To make students acquainted with science and making models using low cost materials, science exhibition was organized at Tirora.

#### Educational tour for learning Natural Resource Management

An educational tour was organized to make students acquainted with the nature and natural resources. From Garada village, a total of 76 students visited natural resource management projects taken up by Adani Foundation.

### 5. Material Support



### Books Distribution to 9th and 10th std. students from 10 High Schools

Adani Foundation observed that many students were not able to buy books due to weak financial condition. Adani Foundation decided to distribute books to poor and needy students of Govt. Schools. Students get books from the Government till 8th std. under Right to Education. But after that, in 9th and 10th std, students need other support to get books where Adani Foundation played an important role and distributed books.

### Solar Table Lamp distribution to 1750 Girl students of 9th and 10th std to promote Girl Child Education

Education is the key to empower girls. Girls Education Programme works on improving lives and providing opportunities for girl students, through increased participation in formal and alternative education system.

#### Apporva Science Fair and Exhibition at Tirora

Students from rural areas proved that they were second to none in learning technology and real requirement of society by showing their talent at Apoorva Science Fair & Exhibition held in Tirora. The Science Fair provided an opportunity to students of remote areas to showcase their abilities. Adam Foundation in collaboration with Association for Research & Training in Besic Science Education, Nagpur organized the event to explain the low cost material models and usage of science in day to day life to the students of backward areas. Apoorva Science Mela and Exhibition was inaugurated on 12th March 2015 at Chhatrapati Dubey School Nagar Parishad Tirora premises. During the two days exhibition, a total of 1500 students, teachers and parents visited the Vigyan Mela.



### Kawai

During the year 2014-15, educational initiatives at Kawai ranged from material support to Govt. schools, Balwadi and launching Disha Project.

#### 1. Material Support to Govt. Schools

Furniture & material support to schools:

- Seating arrangement with 335 sets of table-stool in 10 schools.
- Office furniture to 8 schools like: Almirah, table, chair etc. Sponsorship for sports tournaments & sports material support to schools:

Adani Foundation provided support to state/district level tournaments and also provided sports equipment to all adopted 41 schools

#### 2. Disha Project



Choosing the right career is extremely important for the students to build a bright future. Adani Foundation conducted the first phase of Disha project "Career guidance program" in all 13 secondary & sr. secondary schools of Kawai. A total of 1900 students from class 9th to 12th benefited from the program. Career guidance booklets & other useful material were provided to all students.

#### 3. Support to Balwadi

During the year, various activities were initiated for the development of laborers' children & provide them better future prospects. Various activities such as health checkups, uniform and sweater distribution, celebration of important events like children's day, republic day were carried out at the Balwadis. Learn with fun, drawing, speech, poem, and story & play way method were applied for the holistic development of Balwadi children.

### Surguja

During the year 2014-15, educational initiatives at Kawai ranged from material support to Govt, schools, Balwadi and launching of Disha Project.

#### 1. AVM Surguia - Replicating the Success

Replicating the successful Adami Vidya Mandir (AVM) school model, AVM Surguja was established in 2013. AVM-S provides facilities for the overall physical, mental and intellectual development of the students. All academic and non-academic facilities are provided free of cost to the students. During the academic year 2014-15 the student strength was 295.

Evaluation for the students' performance was also conducted at regular intervals based on the following parameters:

- Ability of understanding Interest Writing
- Cleanliness Extra-curricular activities
- Reading ability Subject-wise performance
- Attendance Creative ability Team work ability
- Taking ownership

Capacity Building of Teachers: Training, workshops and presentation sessions were regularly organized for capacity building of the teachers.

#### 2. Celebration of special events

Several special events during the year marked the educational calendar at Surguja.

Sports Events: Different events were orgnized for girls and boys separately. Significant among them were: frog jump race & Jalebi race, 50m & 100m race, long jump & high jump, kabaddi and teachers' race.

World Hand-washing Day: World Hand Washing Day was celebrated from 13th to 17th October 2014 in 18 schools of the project area in coordination and cooperation with the Education Department. To promote personal hygiene among the students IEC materials were distributed and 535 students took oath of cleanliness.

International Girls Child Day: On the eve of International Girls Child Day, quiz competition was organized in two high schools of project affected villages Parsa and Ghatbarra. Six teams of each school participated in this event and prizes were distributed to the winners.



### Chhindwara

- Material support to schools.
- Distribution of mattings in nearby village school for school children.
- Distribution of school bags in Heverkhedi & Dange Wani villages.



### Dhamra

### 1. Dhamra Port Company Limited (DPCL) Merit Scholarship

33 students from rural schools, who passed HSC Examination securing more than 75 % marks, were awarded the merit scholarship by Dhamra Port.

### 2. Dhamra Port Company Limited (DPCL) DAV Public School

The English medium school is running within Dharma Port premises. Presently it's strength is of nearly 200 students, from which about 80 % students are from local villages. DPCL is facilitating quality education to community children at very low fees.

### 3. Material Support to Govt. Schools

Seven High Schools were provided with all equipment required in a science laboratory along with cupboards, as most of the schools didn't have science laboratory facility for students. Besides this, approximately 450 students of 3 schools were distributed uniforms.

### 4. Mobile Science Exhibition

Over 10000 students of 25 schools in Port periphery and railway corridor villages were covered in the Mobile Science Exhibition Programme. Apart from the exhibition, various experiments on general science were carried out for the students at the schools.

### **Community Health**

# TOWARDS CREATION OF A HEALTHY SOCIETY

No matter how clichéd it may be, but the old adage still holds true that health is wealth. No matter how much we toil to become a progressive and prosperous nation, without enough health care facilities for our people, we cannot achieve that goal. A healthy life is a basic right and a basic necessity to lead a good life.

Access to quality health care services is one of the major challenges that our country faces, especially the rural parts. It has taken us ages to trim down our maternal and infant mortality rates. Yet, we still have a very long way to go to match with the standards of medical and health care facilities available to our counterparts in the developed nations.

Adani Foundation therefore chose healthcare as another core area of operation to contribute its bit in facilitating better health care services in remote areas. The Foundation works with the motto of 'health for all' as it strives to resolve the problems of the marginalized sections of the society by providing easy and equitable access to essential health care services.

The Foundation plays a vital role with its various initiatives in uplifting the health care scenario in the communities it work with. It runs mobile health care units and rural clinics to facilitate quality medical and health care services in remote villages. Besides, the Foundation undertakes several need based projects and initiatives which include regular and specialized health camps for the communities, health card for senior citizens, health-related workshops, de-addiction campaigns, health and sanitation awareness programmes, school health check-ups, etc.

Apart from self-initiated projects and programmes, Adani Foundation also partners with the government to extend its support for government/community/primary health centers located in isolated areas. The initiatives of the Foundation have made a notable impact in the lives of the communities it has worked with by making quality health and medical care accessible to all. Because, we are in action, relentlessly!



Health is the most critical parameter for the development of any community. Adani Foundation, since its inception, has been taking initiatives with a far reaching impact that truly reflects the spirit of Adani Act.

### Mundra

### 1. A Far Reaching Act- Mobile Health Care Units &



To increase availability and convenience of quality health care services to the remote villages, the Foundation runs two mobile health care units (MHCU) covering 34 Villages and 05 Fisherman settlements.. The prime objective of the MHCU is to reduce travel time, hardships and expenses. As many as 113 types of medicines are available in it. Rural Clinics operate in 8 villages of Mundra block, 2 villages of Anjar Block and 1 village of Mandvi Block through Adani Foundation. Here, free health services are given for two hours daily with the help of a doctor and a volunteer. During this year, total 78207 patients were provided with free Health Care Services by MHCUs. 59777 patients benefitted by the medical services at Rural Clinics.

### Ameenaben Mahediali Deliwala

Bhadreshwar is a village approximately 28 kms away from Mundra where Ameenaben stays. She was unstable financially, health-wise and socially too, until she availed help from Adani Foundation at Mundra. Ameenaben settled in Bhadreshwar 30 years ago when she got married. Within 8 years, she could not conceive in spite of medication and lost her husband to heart attack.

Her parents passed away when she was 23 years of age and the only surviving relative she could call her own was her brother-in-law who was also mentally-challenged. Her problems did not end there as she suffered from high blood pressure and stress induced thyroid which required her to take medication as long as she lived.

Slowly her body stopped reacting to the medicines and these did not work. She was forced to take steroids so that her body would respond to medicines but this had its own side-effects. Her weight slowly increased and she gained up to 105 kg! As a result the joints in her legs became weaker and she was bed-ridden. She could not survive without her pills which numbered to 20 per day and if this wasn't stopped she would be forced to live in poverty. That's when she enrolled in the Adani Senior Citizen Health Card scheme through which she could seek medical support.

"Adani is like my Second Son.. I get the services even without asking for it", Amenaben says with tears of joys in her eyes.



### 2. A Strong Support In Old Age - Health Cards To Senior Citizens

To address health care issues related to ageing, Adani Foundation launched a 3 year long pilot project called 'Health card to senior citizens - Adani Vadil Swasthya Yojna', on 20th February 2011 at Mundra. Under this programme, the individuals aged 60 years and above irrespective of their socio-economic conditions were to be benefitted. Learning from the pilot, now senior citizens are being issued a Health Card with the purpose of providing adequate and timely treatment in two categories. The families consisting of aged ones with a yearly income of Rs. 2 lacs or more get a Blue Card. The Blue Card holders can avail diagnosis and treatment at a relieving rate at the Adani Hospital, Mundra. Families with a yearly income of less than Rs. 2 lacs can get a Green Card. In Green Card, the aged people get treated free for illness at Adani Hospital, Mundra up to a limit of Rs. 50,000/- within a period of 3 years. · Total health card holders: 426B

#### 3. An Act To Reduce Malnourishment Among Children


Adani Foundation has launched a project in coordination with ICDS, Mundra for "Reducing Malnourishment in Children of Mundra Taluka" on 6th September 2014 at Adani Hospital, Mundra. Objective of this workshop was to spread information to reduce malnourishment from the pregnancy level. During 2014-15, 10 medical examination camps were organized for identified malnourished children at Adani hospital. Two mega workshops for 93 Anganwadi workers and parents were also organized to retain their interest and make them aware about progress. Out of 73 malnourished children only 7 are now under observation, rest all children are under safe category. Besides this various competitions were organized in collaboration with ICDS to sustain interest of mothers and would be mothers.

#### 4. Urinary Stone - Diagnosis And Treatment



Mundra block of Kutch district is situated on the coastline. Due to salinity and TDS being high in water, occurrence of kidney stone is higher too. As a solution to this situation in question, the organization started a project for kidney stone diagnosis and treatment. The organization organized camps and offered services for diagnosis, treatment, operation and medicines to the patients of Mundra block suffering from urinary stone. A project for patients who need dialysis was thus initiated so that the poor patients can receive the treatment at concessional rates in the nearby, well-equipped hospitals. The main objective of providing dialysis treatment is to help the extremely poor and needy patients live a healthy life. Total 6 patients were supported for dialysis regularly (weekly twice) during this year.

### 5. Creating Healthy Communities Through Health Camps



Various need based health camps were organized at regular intervals to meet specific requirements of the community. Screening camps were organized regularly as per the route map planned in coordination with Adami hospital. During the year, 4 specialty camps and 10 camps for malnourished children were organized and 1124 patients were directly benefitted.

### GAIMS

Gujrat Adani Institute of Medical Science (GAIMS) is the first medical college in Kutch started in partnership between Adani Group and Government of Gujarat in the year 2009. This college was affiliated with Medical Council of India in year 2014 for the MBBS course with seats for 150 students in a year. Gujarat Adani Institute of Medical Science is affiliated with the first digital university "Krantiguru Shyamji Krishna Verma Kutch University". Currently 750 students are studying here.

A teaching hospital (G K General Hospital) with 750 beds capacity has been handed over to GAIMS by the Govt. of Gujarat in which patients of Kutch are getting medical treatment free of cost or at concessional rates. In addition to that, the facility of Hostel for students and quarters for staff members are provided in college campus.

### No. of patients have increased during the FY 2014-15 as under:

Outdoor Patients - From 450 to 600 patients per day Indoor Patients - From 125 to 200 patients per day High-tech laboratory and Radio-diagnosis machines have been installed for providing results at par with corporate hospitals.





### Hazira

At Hazira, different types of camps marked the year which generated very good response from various communities.

### 1. Special Medical Camp for Malnourished Children



Malnourishment amongst children is a national issue of worry.

Adani Foundation strives to pitch in by organizing special camps roping ICDS and PHC medical officer to reach maximum benefits to children, 110 identified children from 24

anganwadis were provided with medical assistance.

#### 2. De-addiction Camp - Freedom that Heals

A de-addiction camp was organized under which various activities were carried out.

**Poster Exhibition:** As part of our initiative "Healthy Hazira Wealthy Hazira" Adani Foundation had designed 75 posters on de-addiction. 3025 youth of the community participated in the event.

**Street-Play on de-addiction**: It was completely an awareness program targeting community at large especially youth. Ten students from class 9 & 11 of Navchetan Vidhyalay- Junagam participated in street plays. Total 3500 villagers were impacted through this initiative.

**Rehabilitation:** Three youths from Suvali Village who were addicted were sent to Parivartan Trust for Rehabilitation on 6th Feb 2015 for 21 days residential treatment programme.

### 3. For a Noble Cause - Blood Donation Camp:

A blood donation camp was organized on 24th June 2014 in which more than 103 donors donated blood.



### Tirora

### 1. Health Care at the Doorstep - Mobile Health Care Unit (MHCU)

Adani Foundation tied up with Help-Age India for providing health care services in 17 villages and a Tirora Nagar Parishad area. The Mobile Health Care Unit (MHCU) visits 22 locations at a defined time and place weekly. The MHCU consists of a doctor, a pharmacist, a social protection officer and a driver. The patients are treated and free medicines are provided to the patients. More than 42,000 patients were treated during the year.

#### 2. De-addiction Awareness Programme

De-addiction awareness Programmes were conducted in 12 Villages. The objective of this Programme was to create awareness among villagers about the problem of addiction, motivate villagers for aborting addiction and create awareness about the impact of addiction. Street plays were performed in villages in the evening time focusing on the societal issues and try to create awareness amongst villagers to become addiction free. Total 7075 villagers took benefit from this programme.

### 3. Fighting the Anemia - Anemia Reduction & Awareness Programme

Screening camps were organized during the year 2014-15. Under Anemia Reduction Programme, meetings of women and adolescent girls were organized throughout the year in 10 villages of Tirora reagion, focusing to

- · Introduce this Programme.
- · Create awareness among women & adolescent girls about anemia.
- · Motivate women & adolescent girls for testing HB



During the year 1471 women and adolescent girls participated in pre-testing in the villages. After testing, continuous meeting were conducted on regular basis. After pre-testing, total 248 women and 197 adolescent girls attended the meeting. During the year 2014-15, a total of 1060 post-testing were completed.

Adani Foundation, in collaboration with SDH (Sub District Hospital) Tiroda, conduct Sickle cell testing camp also. Under this programme, we identified total 46 sickle cell affected women and adolescent girls from villages and linked them with govt. hospitals so that they can avail services through the different schemes run by the health department in this regard.

#### 4. An Act for Vision - Cataract Camp

Adani Foundation in collaboration with Mahatme Eye Bank Nagpur conducted cataract camp in 3 villages. Total 743 patients were examined, out of which 155 were diagnosed with cataract, and 40 have been treated so far.

### Sanitation Awareness Programme



Total sanitation campaign is a comprehensive programme to ensure sanitation facilities in rural areas with a broader goal to eradicate the practice of open defecation. These programs were conducted in 45 schools of 45 villages to aware students about personal hygiene and sanitation practices. Different events such as rallies, street plays, village cleaning drives and school competitions were organized in which 32350 students and community people participated.



### Dahej



#### 1. A Healing Touch - Medical Health Care Unit:

The Medical Health Care Unit (MHCU) is an initiative by Adani Foundation having tie up with Help-Age India for the same. This initiative comprises of a MHCU which has an MBBS Doctor, Pharmacist, a Social Protection Officer and a Driver. This team travels all day in the MHCU at villages and provides free medical check-ups and treatment to all community people. The MHCU has complete set of listed medicines and they travel across sites based on fixed weekly routine. The initiative was started in December' 14 and more than 7000 patients have been treated.

#### 2. Special Medical Camp

Adani Foundation had organized a camp to provide free medical aid in case of any emergency or provide any other kind of required treatment during a large cultural gathering at Lakha bawa temple.

### Dhamra

### Dhamra Port Company Limited (DPCL) Community Health Center:

Nearly 20000 community patients were treated at the DPCL Community Health Centre. Free medicines were distributed and ambulance services provided during emergency needs.

### 2. Health Camps

Over 1500 patients were treated during five mega health camps conducted in the community villages.

### 3. School Health Check-up

Over 3500 school children had undergone free health check-up and given free medicines.



### Kawai

#### 1. Healthcare on Wheels - MHCU

Adani Foundation Kawai started a mobile health care unit (MHCU) service in all 29 villages of surrounding area. Under this free medical treatment & medicines are provided to the people at their door step. A total of 23545 patients were benefited through this initiative. The MHCU also provides service of special home visit/treatment for weak & elderly patients, awareness talk, prevention & guidance about epidemic/seasonal diseases.

#### 2. Support to Govt. Health Center

Under Adoption Scheme of GoR, Adani Foundation provides material & need based support to all 3 PHCs and CHC. 16 complete bed sets for CHC Kawai, necessary equipment & other material (furniture, stretcher, wheel-chair, attendant bench, steel sofa, cleaning equipment etc.) to CHC Kawai, CHC Atru and PHC Aton were provided.



#### 3. Awareness Program & Material:

For the purpose of spreading awareness among people, Adani Foundation has initiated various methods and successfully implemented them to convey message to the people by

- · Spraying Pyrethrum in villages
- Pamphlets distribution about seasonal /water borne diseases
- · HIV/AIDS day celebration with expert's speech
- · Awareness Rally in Atru town
- · Organized slogan competition in MPR school, Atru



### Surguja

### 1. An Enabling Act - Artificial Limbs Distribution Camp

Adani Foundation /Adani Mining Pvt Ltd. had organized a camp for distribution of Artificial Limbs from date 24th to 26th June 2014. It was organized with an aim of extending help to physically challenged people. AMPL has provided limbs to beneficiaries from "Sachet Orthopedic Appliances" Nagpur. Total 27 persons had registered. All of them got guidance, measurement & treatment. Total 25 persons have received artificial limbs or appliances in 2nd phase of camp, which were identified in 1st phase of camp during last financial year, 20 new persons had participated in screening.

#### 2. Campaign For De-addiction

Adani Foundation team organized a campaign with the aim of "Reducing spiral increase of alcoholism". It was organized with the support of AMPL's Medical Team, Village health workers & Self-Help Groups. With the use of "Gaon Chaupal" as a tool, an effort was made to create interest among community to reduce or totally give up locally made alcohol (Mahua) drinking habit. A total of 103 people participated.

#### 3. Female Health Check-up Camp

With the aim of "Addressing issues of female health at their village" these camps were organized from 23th to 27th Sept.' 2014 in each of the 4 villages Kete, Salhi, Parsa & Ghatbarra. To maintain respect & privacy of rural tribal females these camps were facilitated by only female team. Total 382 patients were examined during the camps.

#### 4. Medical Dispensary



A medical dispensary is situated at Shivnagar village. It has a team of 2 Doctors, 1 Physiotherapist, 1 Lab Technician, 1 Pharmacist, 1 Aaya & 1 helper. To address community better, 6 local Multipurpose Health Workers & 5 members of Adani Foundation always support in all activities held in periphery. There are facilities of OPD, Primary treatment & Referral for indoor treatment. More than 3600 patients have been treated in this dispensary during the year.



### Shimla/ Sainj

### On the Path of Healthcare....

Adani Foundation Sainj, Shimla has successfully completed its six years in November 2014 since its inception in the year 2008 and running successfully for the seventh year in Himachal Pradesh. Adani Foundation Sainj is well committed to its health care activities in the districts of Shimla, Kullu and Kinnaur of Himachal Pradesh. Adani Foundation Sainj is running its Mobile Health Care Unit as well as health center at Sainj for successful seventh year. During this financial year 2014-15, Adani Foundation Village and Post Office (VPO) Sainj has visited 33 villages through Mobile Health Care Unit and treated & reviewed 7778 patients and 767 patients were treated at the Health Centre at Sainj. Adani Foundation VPO Sainj organized 25 medical camps in different villages. In these medical camps 1847 patients were treated.

### Sustainable Livelihood Development

### THE POWER OF FINANCIAL FREEDOM

Adani Foundation holds a holistic approach to its social development initiatives which inculcates a strong need for empowerment of the communities. At Adani Foundation, we have strongly believed that social empowerment comes from financial empowerment. And the key to financial empowerment is self-reliance and financial freedom.

In order to help the marginalized communities live with dignity, Adani Foundation diligently strives to create ample employment and self-employment opportunities for the members of the communities. The Foundation works in the direction of skills development in various fields to enhance the employability of the people and provide better opportunities to earn their livelihood.

Under the Sustainable Livelihood Development drive, Adani Foundation focuses on identifying the gap

between the capabilities of the local youth and available options for employment. Based on the analysis, the Foundation strives for capacity building of the youth to bridge the gap. Skills development training provided by the Foundation plays a significant role in making the youth capable of self-sustenance by enhancing their employability in the industry. Through skills training, the Foundation also helps specific communities like fisherfolk to gain financial freedom in economically weak period by indulging in alternative vocations that help them stay self-reliant.

Besides this, Adani Foundation runs several other schemes and programmes in direction of material support, shelter support, alternative income generation support, women empowerment etc. with an aim to help the communities for securing sustainable livelihood. Needless to say, we are in action, relentlessly!



Earning livelihood is not only about sustenance of the family and self, but also about self esteem. Adani Foundation has been a great enabler for the community members to get suitable employment, learn employment oriented skills and enhance their current livelihood with value addition through innovative methods. Various successful efforts taken up by the Adani Foundation speak for themselves and further the philosophy of Adani Act.

### Mundra

#### 1. Acts that Define Development of Fishermen

Fisher-folk community is a major stakeholder community at the port town of Mundra. Adami Foundation had initiated various schemes for fisher-folk related to Education, Health, Sustainable Livelihood and Basic infrastructure facilities.

### 2. Vidya Deep Yojana



This FY, a Balvadi for the kids of age 2.5 to 5 years has been constructed at Zarpara and upgraded in Juna Bandar, Luni Bandar and Bavadi Bandar. Balwadis for the kids of fisherfolk community are built to inculcate a sense of awareness about health, hygiene, cleanliness, discipline, regularity and importance of education at an early age for the children and among the parents. More than 140 children avail benefits from Balwadis every year.

### 3. A Supporting Act - Machhimar Sadhan Sahay Yojana

Fishing material support was provided by Adani Foundation at Mundra. According to the needs of the fisherfolk, a total of 71 fishing nets were provided this FY. Fish market has also been designed and constructed to hold 40 platforms for selling purpose; there are 6 big shops with shed and one sanitation room with toilet facilities. The idea is to provide an appropriate space for sale of fish which would eventually result in fetching a good price.

### 4. Machhimar Aawas Yojana - Creating Shelters for Growth



Appropriate shelters for the fisher-folk who reside near the coastline all year round except the rainy season have been constructed. Total 139 Shelters have already been handed over to fisherfolk families at Juna Bandar and 110 shelters at Luni Bandar.

#### 5. Machhimar Shudhh Jal Yojana

Water tank platforms have been constructed and tanks have been set up in order to provide clean potable drinking water to the community. Close to 80,500 litres of water was supplied through this initiative this year. Total 9 water tank platforms have also been constructed.



## 6. Machhimar Arogya Yojana - An Act to Safeguard Health

Mobile Health Care Unit (MHCU) are run by the Foundation since 2009. The MHCU is not only for the Vasahats/Settlements but is also available near the coast where the fisherfolk can avail the facilities as and when needed. Total 10382 fisherfolk family members were benefitted by MHCU during the year.

# 7. Machhimar Akshay Kiran Yojana - Bringing Light to Life

79 Solar Light facilities have been installed at the fisher-folk residences on the coast to provide lighting facilities at night.

#### 8. Machhimar Sugam Path Yojana

Fishermen used to have problems of traveling from Vasahat to the village. To solve this issue and facilitate travel route, approach roads were constructed to Vasahat. As per requirement, GSB road, earthen road, metal road etc. were provided and a 13.7 Km approach road was constructed.

# Machhimar Ajivika Uparjan Yojana – Creating New Avenues for Employment

Mangrove plantation was introduced as an alternative source for income generation. Technical assistance was provided by Adani Foundation and 100 hectares were given for plantation and more than 100 fisherfolk families were benefitted. This was carried out during seasons when fishing is banned by the authorities due to turbulent Sea and for fish breeding season which is termed as 'off season' in the fishing community.

# 10. Machhimar Kaushalya Vardhan Yojana - An Initiative for Skill Development

With an objective to impart technical skills to fisherfolk and resolve employment issues in off season, various training programmes for youth have been initiated by the Foundation. 115 youth have taken IT-Basic Computer training at Juna Bandar, Luni and Navinal & Zarpara. A new center for computer training was started in Zarpara. Total 30 students have benefitted from this training this FY.





# 11. Cultivating Action in Agriculture and Animal Husbandry



The organization has carried out remarkable activities in agriculture and animal husbandry sectors. It is a basic need that the regional occupation of animal husbandry is supported and gets a much needed push. Total 1,08,843 maan of fodder costing around 192.36 lakhs has been provided.

#### 12. Tree Plantation Programme

The organization involves people of the village in the tree plantation programme. Awareness programmes, essay writing in schools, drawing competition etc. are organized for creating awareness regarding tree plantation. The organization carries out tree plantation programme at regular intervals. During the programme, awareness for environmental protection is also created among the village people. This year we have planted more than 10000 trees to keep our environment clean.

#### 13. Empowering Women

Women Empowerment Training Programme in Coordination with VRTI- Vivekanad Research and Training Institute has been started for two groups - Training for preparing washing powder, phenyl, soap, shampoo, gel, tile cleaner and many more usable items.

#### 14. Adani Skill Development Centre (ASDC)

The objective of this center is to impart different kinds of training to the students of 10th, 12th, college or ITI pass outs from surrounding areas. Thus, various employment oriented programmes are organized to optimize the skills, art and knowledge through proper guidance and direction. Due to social and cultural traditions, various training programmes are organized at rural level for women so that they can gain its benefits

- a. Training for Crane Operator
- b. Electrical work pertaining to the company
- c. Operation and maintenance of call handling system
- d. Checker training
- e. Gate Keeper and Gate Operator
- f. Mechanical work pertaining to the company
- g. Automobiles repairing
- h. Security training
- i. Non-technical trainings:
- j. IT basic computer
- k. Tally ERP 9
- I. Spoken English
- m. Stitching and beauty parlor

Adani Skill Development Center has imparted various training to 800 people during April 2014 to March 2015.





### Dhamra

# 1. Women Empowerment through SHG Group Formation

Various SHGs have been formed in Dhamra for women to provide them income generating trainings such as paddy crafts, agarbatti, papad making etc. and linked them with various organizations for marketing of their products. Fourteen women of Kaithakhola G.P. were trained and supported for making handicraft items using paddy. Their SHG has been linked with a local NGO for marketing of the items. Another 30 women of Amarnagar village in Dosinga G.P. were trained and supported for agarbatti making. Their SGH has been linked with Odisha Rural Development and Marketing Society (ORMAS) for raw material support and marketing of their products. 15 other women of Sushiladelpur and Rambhila areas were trained and supported for making 'badi & papad'. They have also been linked with ORMAS.



# 2. Agricultural Initiatives & Animal Husbandry - Trainings & Vaccination

Two farmer groups were formed in two periphery panchayats of 50 farmers as members. The farmers groups are linked with Orissa University of Agriculture & Technology (OUAT) and Krishi Vigyan Kendra, Ranital for necessary technical input and other support. Adani Foundation facilitates training and



workshops for the farmers. Nearly 1200 cattle have been vaccinated and treated during vaccination drives.

#### 3. Bouys for Gahirmatha Demarcation

The Gahirmatha Marine Sanctuary was demarcated by putting buoys with a cost of nearly Rs 50 lakh. The idea was to demarcate the 'banned fishing' area for the benefit of the local fishermen as well as to protect the endangered marine life like Olive Ridley Turtles.

#### 4. Support to Fisherfolk Community

Over 100 fishermen are regularly using a Solar Fish Dryer installed by Adani Foundation within Dhamra Fishing Harbour. The fish dryer is beneficial to fishermen in drying their fish in less time and with proper hygiene. A large number of fishing trawler crew and workers from different ice factories operating in Dhamra and nearby areas were trained on safety and rescue measures.

#### 5. "Swachchha Bharat" Campaign

A cleanliness drive was organized in the region that included:

- a. 30 large dustbins were distributed as part of 'Swachchha Bharat' campaign jointly conducted with Bhadrak police
- b. Village cleanliness drives were conducted in adjoining villages

#### 6. Prakruti Saathi Award

Ten individuals selected from various parts of Bhadrak district were awarded on the occasion of World Environment Day for doing commendable job in the field of environment protection.

# Hazira

#### 1. Care for Environment

One Tree One Life initiative was started under Clean Hazira Green Hazira campaign in coordination with Divya Bhaskar Group. The motto of this activity is to directly benefit the environment. For this campaign, one Green Ambulance was designed to advertise about the helpline no. for obtaining help in tree plantation.

2466 trees were planted in the catchment area by students of 5th to 8th.

#### 2. SHG Formation & Exposure

A training session was organized to help women understand the importance of Self Help Groups (SHGs) and its working and benefits. After the 3 day training, an SHG group of women was formed. The group was taken to an exposure tour of other SHGs and shown the different activities carried out by them.



# Dahej

#### 1. Empowerment for Employment - Skill Development Trainings

For promoting Sustainable Livelihood Development, Adani Foundation has provided different forms of Skill Development Training to Women of villages of Jageshwar, Ambetha and Luvara in beautician course and agarbatti making course, Nearly 150 women participated and were enabled to start their own small scale business and create their own source of earning.



#### 2. Funding for Fishing License to Fishermen of Jageshwar

About 20 fishermen from Jageshwar were given financial support for obtaining license for taking up fishing as their source of earning and running their trade smoothly thus empowering them in their source of income generation.



### Tirora

#### Biogas Construction Programme - Built 80 Units in 7 Villages.

Adani Foundation observed that women have to toil in the village for fetching fuel wood. This consumes lots of time and energy. This is also not good for their health as the smoke is hazardous for lungs. Construction of Biogas in the rural household is an alternate way of cooking where time and toil are reduced manifold. It is environment friendly and non-pollutant. Rural People can also operate it very easily. During the year 2014-15, Adani Foundation constructed 80 biogas units in 80 households. It is expected to save about 5 tons of firewood in each household every year. Moreover it will also reduce the respiratory problems in women. Adani Foundation explained the benefits of biogas to the community especially to women. Adani Foundation has also tied up with Khadi Village Industry commission for the construction of biogas. Biogas as cooking fuel reduces women's drudgery by reducing their workload for collecting, carrying and storing firewood. Biogas is a clean, pollution less, low cost fuel. This allows women to cook in a smoke free environment and thus reduce indoor pollution. Cooking in a smoke free environment has a positive impact on women's health.

# 2. System of Rice Intensification (SRI) with 240 Farmers in 240 acres of land

Adani Foundation encouraged farmers to adopt SRI technique under Livelihood Development Programme. Under this programme, a total of 240 farmers from 11 villages were covered. The training programme was conducted for farmers in collaboration with Block Agriculture Department Tirora; to increase the knowledge of farmers about the new technique which increases the production.

#### 3. Go-vigyan - Blessings of Mother Cow

Livelihood in Gondia is entirely dependent on agriculture for the small and marginal farmers. In order to promote the dairy activity as an alternate source of livelihood in this region, the government has been promoting the high milk yielding exogenous species of cows as part of the relief package for the needy farmers. A series of training programme is being conducted with Go Vigyan Anusandhan Kendra Deolapar.

#### **Objectives:**

a. To motivate farmers for cow based farming.



- To impart technical skills to farmers for using byproduct of dairy farming.
- To introduce farmers about various agriculture practices and other livelihood options.
- d. To motivate farmers for adopting various practices in agriculture, animal husbandry and agriculture based activity at their own place and their own cost.
- e. To promote organic method for agriculture.

A total of 578 participants have taken part in the training programmes.

#### 4. Tree Plantation Programme

Healthy environment is essential for villagers, to make their village healthy and beautiful. It needs plantation and greenery development everywhere. Through this Programme, we have covered a total of 22 villages and also made village roads beautiful. These programmes really help us to make green environment as well as create awareness in villagers about environment. 1233 plants and 21 tree guards have been provided.

# 5. Computer plus Training Programme for the Rural Youth

To create employability amongst rural youth, Adani Foundation started Computer plus Training Programme. Adani Foundation selected 21 students and gave training to them about computer as well as soft skills so that the trainees can enhance their knowledge and bright up their future prospects.

# Kawai

#### 1. Plantation / Social Forestry at NH-90

It is planned to manage the area dedicated for social forestry for five years and then return to the village panchayat to generate products or revenue as per their suitability. 1100 Avenue Plantation was done on approach to National Highway on the both sides of the power Plant.

#### 2. Cleanliness is Godliness - Swachchta Abhiyan

Swachchta Abhiyan (cleanliness drive) was launched in the region. Various activities were organized such as awareness rally, pamphlets distribution, slogan competition for children, plantation & spreading of message of Sanitation / save environment.

#### 3. Skill Development Training Programs

Skill development programs for farmers were organized during the year. Meetings with farmers & data collection were organized to improve agriculture practices under project "KRISHI KAUSHAL".







# Surguja



#### 1. Strengthening Livelihood through SHGs

Nine Self-Help Groups were formed. With day to day interaction, monitoring and motivation, we have built their capacity to act as per government's Sustainable Rural and Livelihood Mission (SRLM) scheme. To build capacity of all members of SHGs, we have cooperated training programs of SRLM, which have been organized at village level. We have also facilitated such trainings with sharing of experiences & information about other successful SHGs. We have organized total five SHG's Exposure visits at well run & income generating SHGs within district. We have also engaged SHGs in income generating activities at AVMs to & various health camps.

#### 2. Empowering Farmers

We have been coordinating with government's agriculture department at district & block level to build better link between farmers & government scheme. We have raised level of awareness among farmers through regular two-way sharing of issues & solutions for better cropping. We have taken small initiatives & collected healthy tomato plants from AMPL's horticulture team & distributed to active farmers, for better production of vegetables.

# Rural Infrastructure Development

# A BETTER PLACE TO LIVE FOR ONE AND ALL

Infrastructure is the most tangible form of development. It is something we leave behind as the legacy for the future generations. Our cities have the best of the assets that put them at a decent position on development rank. But, that's not the case with rural India. There are several villages where even the most basic infrastructural facilities like roads and sanitation are absent. There are regions where people are deprived of pure drinking water. Things need to improve and they Improve with combined efforts of all.

At Adanl Foundation, we work closely with the communities to resolve their basic infrastructural needs to make their lives easier. The Foundation invests in promotion, protection and upgradation of the infrastructure in the regions it works in. Inclined to make the world a better place to live for one and all. Adani Foundation does its bit by developing sustainable rural infrastructure in line with its goals of overall social development.

The Foundation's RID (Rural Infrastructure Development) projects encompass water conservation projects, drinking water projects, education infrastructure projects, improvement of roads, solar street lights, construction and reconstruction projects, sanitation facilities and community need based infrastructure projects. While there have been challenges, we have put our determined efforts to find solutions and our efforts have paid off in terms of benefits to the rural communities. This keeps us in action, relentlessly!

Adani Foundation is relentiessly making efforts to make a meaningful difference in the communities it works with. The spirit of Adami Act rightly converts these efforts into fruitful

### Mundra

#### 1. An Act of Harnessing Water Resources - Water **Conservation Projects**

Being situated in the coastal region, Kutch District has issues of safe drinking water. There is a scarcity of potable water. Also, the water contains high amount of TDS, High TDS is the root cause of bone and kidney diseases. In almost all villages of Mundra Taluka, people use ground water for drinking purpose. Due to this situation, Adani Foundation has initiated construction of check dams and pand deepening works in past years. This year Adani Foundation carried out pond deepening in three villages of Mundra Taluka, namely Siracha, Luni and Vadala increasing the water conservation capacity by approximately 27000 cmt.

#### 2. Making Drinking Water Clean and Pure

Potable drinking water is the most basic requirement of any village. For better health and hygiene of village, drinking water should be clean and pure. Considering the need, Adani Foundation has initiated the drive by providing RO Plant at Vadala Village for providing clean drinking water. The present source of water for village has high TDS. The plant at present is providing safe drinking water of approximately around 2400 liter per day.

#### 3. Creating Better Infrastructure for Education

Adami Foundation carries out the construction of assembly hall, classrooms, computer labs, space for midday meat, playground, school walls, washrooms etc. as per the needs and preferences of the school. It is almed at up-grading facilities in education sector. This year we have constructed Prayer shed and Water pipe line for water supply to school at Mota Bhadiya village.

#### 4.Building a Medical Centre

The Foundation constructed a Medical Centre at Wandi Village to upgrade rural clinics. The village has population of fisherfolk community.

## 5. Upgrading Skills Community Skill Development

Community Skill Development Center is one of the best examples of Kutchhi Traditional Art mud work. It is divided in three parts. One big hall is utilized for computer coaching, while other small rooms are used for medical center and office work.

#### 6. Upgrading Living standard of Fisherfolk

In order to raise the standard of living of the fisherfolk community, Adani Foundation assisted in providing good roads to reach sea shore settlements, platforms for drinking water, solar light, space for drying fish, etc. The construction of temporary residences for fisherfolk in order to provide them with a healthy lifestyle is constructed by Adani Foundation under the Fisherman Housing Programme. During 2014-15, the Foundation has strengthened approach roads; constructed Community Centre at Navinal , Balwadi at Zarpara, and Community Development Centre at Mundra.





### Hazira

# Various Community Development Works have been carried out by Adani Foundation in Hazira region:

- · Construction of Gram panchayat Building- Damka
- Reconstruction of 11 Halpati Aavas Vasva & 17 Halpati Aavas- Suvali
- Installation of 50 Solar Street Light at Rajgirl
- Indira Avas Renovation & new toilets with Soak Pit at Damka Halpativas
- Renovation of school including tollet facility at Hazira and Damka
- Construction of sanitation block at Navchetan School at Junagam



### Dhamra

Various community need based infrastructure activities have been undertaken at Dhamra:

#### 1. Improvement of Village Roads

Spreading metal strips along with surfacing at many places was done on 4 major village roads. Total length covered is 8 km.

#### 2. Tube Wells

Total no of 14 tube wells sunk at different places in community

#### 3. Furniture to School

One school in the project affected area was furnished.

#### 4. College and School Building

One college and one school were supported for construction of additional classrooms.

- 5. Market drain constructed near the port area
- 6. Rest shed for bus passengers constructed

### Chhindwara

- Installation of 4 Solar Lights in Dangewani Pipariya and Thaweriteka and RCC Benches in Nearby Villages.
- Extension of retaining wall in stop dam at village Dange Wani Pipariya
- Service for waterproofing in terrace of Chausara Primary School Building and distribution network for water supply in Heverchedi School.



# Dahej



#### 1. Strengthening the Education Infrastructure

The Primary Schools of Jageshwar, Luvara and Lakhigam required some amount of renovation work within the school premises. This was undertaken by Adani Foundation. This included construction of multi-purpose hall at LAKHIGAM School. An amount of Rs. 35 lacs was spent in this renovation benefitting around 1200 students and 20 teachers.

#### 2. Building the Pillars of Education

Dahej and Lakhigam villages were not having a constructed Aanganwadi within the villages. Adani Foundation constructed two new buildings for Aanganwadis in these two villages.

#### 3. Providing Green Energy

Solar street lights were installed in Jageshwar village to curb the problem of complete darkness on the village roads post sunset. These lights solved the problem of darkness at night in the village to a great extent.

Various other Community Development Works have been carried out by Adani Foundation inDahej region:

- Renovation of 60 Indira Aawas at Jageshwar.
- Renovation of 78 No. of Navinagri at Lakhigam
- Reconstruction of 10 No. of houses at Navinagri -Lakhigam
- Reconstruction of 17 No. of houses at Rathod Falla –Lakhingam
- · Reconstruction of 11 No. of houses at Luvara.





### Tirora

#### 1. Upgrading Infrastructure for Education.



One classroom and kitchen room was constructed for the students of ZP Primary School Sindhitola. The constructed classrooms will improve school environment and make better infrastructure available to the students. After the construction the enrolment in the school has increased by 100%. Three classrooms and tollet block were built for the students of ZP Upper Primary School Khairbodi village.

#### 2. Taking "Swachchh Bharat" Abhiyaan Ahead

School sanitation and hygiene education is an essential component of the total sanitation campaign. This includes provision of toilet infrastructure. It recognizes the role of children as the best change agents in absorbing and popularizing new ideas and concepts of sanitation not only in their school but in their families and neighborhood also. Taking this campaign forward, Adani Foundation has constructed toilet units in 7 Schools of 6 villages.

#### 3. Drinking Water Facilities



Adani Foundation took initiative and installed 2 hand pumps by drilling bore wells. Also, repairing and installation was carried out in schools to provide safe drinking water to students. Adani Foundation drilled a total of 37 bore-wells and installed hand pumps on these bores. These include providing hand pumps on bore in two school premises as well. The installed hand pumps in the villages will help the community to get potable water at a shorter distance.

# 4. Water Conservation Projects - Pond Deepening & Check dams



Adani Foundation took initiative under water conservation and rain water harvesting programme to harvest rain water. The initiative covered total 12 villages and 13 ponds to harvest more rain water and helped farmers for irrigation and other activities. This helped in increasing groundwater level and other water based livelihood activity for farmers. Most villagers use this water for irrigation as well as fishery based livelihood development programme. Adani Foundation also constructed check dams in the area. The small dams retain excess water flow during monsoon rains in a small catchment area behind the structure. The major environmental benefit is the replenishment of nearby groundwater reserves and wells. The water entrapped by the check dam, surface and subsurface, is primarily intended for use in irrigation during the monsoon and later during the dry season, but can also be used for livestock and domestic needs.

#### 5. Solar Street Lights in village

Adani Foundation assisted in installing 110 solar street lights, at 55 locations. This will help villagers to easily access roads during night. Also, it will control antisocial activities in the village and increase security.

### Kawai

#### 1. Building Infrastructure for Health



Adani Foundation constructed a female ward for the CHC at Kawai. Kawai Health Center treats more than 250 OPD / day but there is a serious unavailability of basic facilities. Considering severity of the issue, AF initiated rejuvenation of CHC & constructed 20 bed capacity wards with furniture & necessary equipment's.

#### 2. Infrastructure to Aid Education

To provide basic infrastructure in the govt. schools, AF has undertaken the construction of boundary walls, playgrounds, renovation of class rooms, toilets, sheds etc. in the schools.



#### 3. Sanitation Facilities



To resolve the Issue of Girls' toilet at Jawahar Nayoday Vidialya Atru, toilet blocks were constructed especially for girl students.


#### 4. Creating a Platform for a Sporting Talent

There was a need and demand for a playground in Chhippabard. Adani Foundation took up constructing a playground considering its utilization and future scope. State & national level tournaments are now organized on this ground. It helps in providing platform & better infrastructure facility to local talent. This is the only big ground in the whole block area. Adani Foundation has also contributed significantly in development of popular Baran Public Park which is utilized by large number. Additionally, the Foundation has constructed CC road at Bamori Village and Minor bridge at Aton to facilitate rural local communication.



# Surguja

#### 1. Water Related Projects



Parsa Village area is very scattered, so more hand pumps were needed to provide drinking water to people in the proximity area. The Foundation is facilitating community by developing resources of drinking water. We have provided facility of 12 additional hand pumps with drilling & installation during the year in village Parsa.

#### 2. A New Building for Higher Secondary School

We have helped in the development of the area by providing new school buildings & value addition in old buildings. We are constructing a new building with 12 rooms & other allied assets for Higher Secondary School at district place Ambikapur.

#### 3. Construction of Individual Household Toilets

Poor practices of sanitation (mainly open defecation) & water (handling & usage) increases various types of illnesses. Their spiral effect creates barriers for development and better human life. 254 tollets have been constructed benefiting 1100 people.



#### 4. Various community need based works

Various community need based works such as construction of approach roads, panchayat bhavans, electricity supplies etc. have been undertaken at Surguja.





# Mundra

### Swachhata Abhiyan A Move Towards A Clean Living

A cleanliness drive was initiated by the Adani Foundation at Juna Bandar, Mundra, a port town in Kutch region of Gujarat. Juna Bandar is a temporary habitat of fisherfolk community, where the families of fishermen live for around 8 months a year. Having a clean and hygienic living environment is utmost important both for their health and profession. The cleanliness drive envisaged by the Adani Foundation was quite comprehensive, including all aspects pertaining to clean and hygienic living, whether at home or at work. Several activities were carried out during the day that marked the uniqueness of this drive.

The employees of the Adani Foundation, students of Adani Vidya Mandir and ADAV School (both run by Adani Foundation) and the fisherfolk community members participated whole heartedly in this drive for cleanliness and hygiene. With t-Shirts, caps, masks, brooms and a strong desire to contribute to this drive, charged up the atmosphere.

Or. Priti Adani, the Managing Trustee of Adani Foundation, interacted with the women members of the community and emphasised the importance of healthy and hygienic practices



in day to day activities. Through her interaction with community members, Dr. Priti Adani emphasized on the necessity and importance of using toilets which were built for them by the Foundation a few years back. She urged them to inculcate the habit of using toilets for all the members of family.



## Support To Traditional Artisans - Women's Day

Empowering women and broadening their scope for economic opportunities, Adani Foundation initiated various training programmes for the women groups of Mundra Taluka in coordination with VRTI (Vivekanand Research and Training Institute). Adani Foundation has given training to more than 150 Women of 9 villages.

#### Howzzzattt? Adani Premier League

Adani Foundation had arranged a cricket tournament "Adani Premiere League" for five days for Fisherfolk Community in which, a total of 16 teams of fishermen participated. It was organized to promote healthy sports.

#### Cycle marathon for fisherfolk community

Adani Foundation organized Cycle Marathon for fishermen at Mundra. 56 fishermen took part in the marathon. Fishermen of age group from 20 to 45 Years were eligible to take part in marathon. Marathon run was approximately 20 Kilometres.
